Membership Fees

Thank you for your interest in membership at Treasure Oak. The application process and fee structure for new members is as follows:

Active member status:

- Prospective members complete a TOCC membership application and secure the signatures of three sponsor members.
- Application is submitted to the club with a \$100 application fee (to be applied toward initiation fees).
- Total initiation fees are \$2,000 paid over a five (5) year period. Upon membership approval, and if an opening is available, applicant is placed into an Associate (non-voting) membership. Associate member enjoys use of all club facilities.
- Application Fee = \$100.
- 1st Month = \$200 (\$70 dues + \$130 initiation fee)
- 2nd Month–60th month = \$100 (\$70 dues + \$30 initiation fee)
- 61st month + = monthly dues
- When the member completes paying the first \$800 of the \$2,000 in initiation fees, he/she will be placed on the Active Membership list.

Initiation fees may also be paid in full if the member so chooses.

Junior Associate member status:

- Membership is available to all new applicants under the age of 35 until the eldest member covered by the membership reaches his/her 35th birthday.
- Prospective members complete a TOCC membership application and secure the signatures of three sponsor members.
- Application is submitted to the club with a \$100 application fee.
- The Associate Member is not required to pay an initiation fee but likewise has no voting power. Monthly dues are \$70.

Military Associate status:

- The Military Associate Membership program is available to all new armed forces applicants. Membership in this class is restricted to active armed forces personnel as defined in the United States Code, Title X.
- Prospective military members complete a TOCC membership application and secure the signatures of three sponsor members.
- Application is submitted to the club with a \$100 application fee.
- The Military Associate membership is limited to a two (2) year term.
- Any member under this program can choose to pay his/her initiation fee at anytime and achieve Active membership status. The application fee will be applied to the applicant's active membership equity if the applicant transitions to Active.
- The Military Associate is not required to pay an initiation fee but likewise has no voting power.
- Monthly dues are \$90.

Corporate/Business Associate status:

- Corporate/Business memberships are available to sponsoring corporations/businesses whose employee(s) desire to become members.
- Prospective members complete a TOCC membership application and secure the signatures of three sponsor members.
- Application is submitted to the club with a \$100 application fee. This fee can be a corporate/business check.
- The remaining \$2,000 will be invoiced to the sponsoring corporation/business in two (2) lump sums. The Corporate/Business Associate has no voting power.
- Monthly dues are \$70. The sponsoring corporation/business will be billed each month for dues and guest fees.

Competitive Tennis Associate status:

- Prospective Junior tennis player's parents/guardian complete a TOCC membership application and secure the signatures of three sponsor members.
- Application is submitted to the club with a \$100 application fee.
- Monthly dues are \$40. As soon as the member's student and/or tennis status changes he/she will no longer be eligible for this membership category. The Competitive Tennis Associate has no voting power.
