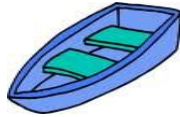

Dues Increase

Your membership at Treasure Oak provides you with social opportunities to create lasting friendships and memories in a safe environment for the entire family. In addition to tennis, we offer a newly renovated workout room, a large swimming pool with diving board, access to boating and fishing, rental facilities and beautiful grounds.



Coming soon, the club will offer snack and beverage service at "Deuce's Court" in the clubhouse.

Despite our best efforts to decrease costs, the Club has been operating at a deficit for the past three years. We cannot sustain our monthly financial obligations without either an increase in membership or an increase in dues.

We have tried to increase membership for almost two years to no avail.

At this time, we have no choice but to increase dues.

The Board has approved a \$10 dues increase effective February 1, 2011. Dues will be as follows:

\$80 - Active and Associate members with initiation fee paid.

\$80 - Military and Corporate Assoc.

Current rate +\$10 - Active members still paying initiation fee

\$40 - Golden members

\$50 - Competitive Tennis Associates

We are proud of our facility and will continue to commit our efforts to the overall benefit of the club.

Attention Team Captains and Players

New Non-member Team Player Fee

Non-members are not permitted on the roster of any TOCC team without the approval of the Board of Directors. Requests must be submitted to the Board in writing no later than the Board's monthly meeting prior to the USTA League Coordinator's roster deadline.

Each request must be signed by each TOCC member of the requesting team.



The Captain of the team will be billed a \$100 non-member player fee for each nonmember team player.

If the non-member team player joins the Club within one year of the date he/she played on the team, he/she will receive \$100 credit toward their application fee.
